

**KNOWLEDGEPANEL  
OFFICIAL SWEEPSTAKES RULES AND REGULATIONS**

**WHO CAN ENTER:** This Sweepstakes is open to all persons thirteen (13) years of age or older who are legal residents of the United States and are active panelists on KnowledgePanel at the start and end as of the start of each sweeps period as defined below beginning with **August 1, 12:00 a.m.** (Eastern Standard Time).
